As of May 31, 2023, the 2021 Operating fund balance is \$120,998.46 (58,430 is earmarked as reserve funds to transfer for special projects) (\$10,000 were moved from this account to a new Money Market account to be used as security for the Bayshore credit card.

As of May 31, 2023, the 2022 Operating fund balance was \$25,665.04

As of May 31, 2023, the 2023 Operating fund balance was \$40,656.60

As of May 31, 2023 the 2024 Operating fund balance was \$1,940.00

As of May 31, 2023, the Long Term reserve fund balance is \$370,812.59

As of May 31, 2023 the secure Money Market account is \$10,000.00

Accounts receivable balance as of May 31, 2023 is \$ 20,919.15

Current Liabilities including accounts payable and payroll related items total \$23,972.97 as of May 31, 2023

Contingency Fund balance as of May 31, 2023 is \$17,250.00

There were 5 property transfers in May.

The four directors who were authorized to be signers for the bank accounts have been approved by the bank to sign. Bayshore Beach Club is in the process of applying for a credit card so that Bob Tunison can purchase supplies.

Our taxes were filed by the May 15 extended deadline.

NO ACTION ITEMS

RECAP OF TASK STATUS IN PREPARATION FOR BAYSHORE SPRING/FALL ACTIVITIES:

I returned to work on April 17th following recovery from a major surgery on January 30th. The following is the status on tasks which needed to be completed in preparation for Bayshore Spring/Summer seasons:

POOL:

As voted on by the board of directors during the January. 2023, a new pool heater was purchased and installed in mid-April. The final cost of the heater plus installation was below the board approved limit by approximately \$1,000.00. The heater was thoroughly tested during the last two weeks in April, passed all tests, and has continued to run flawlessly since the opening of the pool on Wednesday, May 24th. In preparation for the pool opening on May 24th, the main pool filters were replaced with new cartridges, leaks in the filtration system were repaired, and the chlorination system was re-piped to provide a more efficient system of feeding chlorine to the pool on a daily basis. The pool was brushed and vacuumed 7-times to remove all debris and algae from the pool and the pool water was balanced without encountering any problems.

The pool deck and patio were pressure washed along with all pool patio furniture and the furniture, tables, umbrella were set around the pool and on the patio prior to the pool opening. The men's and women's locker rooms were deep-cleaned as well.

Pool chemicals for the first part of the season were purchased and delivered prior to opening as well as janitorial supplies for the clubhouse in general. All three janitor closets were cleaned and re-stocked prior to the season.

Finally, all publications (pool schedules, pool rules, member sign-in sheets, renter sign-in sheets, and pool attendant work schedules and payroll forms were created and printed for the season. Pool Attendants Jenny Lamb and Pat Lenz returned for the 2023 season and a new

attendant, David Smith, began his first day of work. All attendants have been doing a great job since the beginning of the season.

CANAL WALK-WAY:

The canal walkway has been considerably widened by removing weeds both on the path as well as on each side of the path.

MACKEY PARK:

Mackey Park has been mowed and trimmed and was mowed and trimmed for the second time this season approximately 10-days ago.

DOGGIE STATIONS:

The containers used doggie bags as well as the containers for the supplied plastic bags was inspected. As a result, the contained for used bags at Mackey Park will be replaced in the next week to ten days when the replacement used is received from our supplier.

CLUBHOUSE:

All clubhouse windows have been cleaned (as well as windows on the first floor) and the wood floor in the ballroom has been re-sealed.

SCOTCHBRROM AND BLACKBERRY GROWTH:

All new-growth scotchbroom and blackberry growth has been removed from behind the clubhouse, at Mackey and Hilton Parks, and at other areas which our association is responsible for maintaining.

CLUBHOUSE US FLAG:

After many months of delay, the flagpole lanyard at the top of the flagpole has been re-strung and the flag is again flying at the clubhouse. The long delay was due to our inability to locate a company able/willing to donate the use of their "cherry picker" to get this task done (multiple fire departments as well as Spectrum...our cable provider...were unable to accommodate our request and the cost of renting a cherry picker was just under \$400.00 to get this 10-minute job done. To my great relief, Kenn Apel was able to secure Pioneer Cable to donate the use of their cherry picker and the job was completed.

CLUBHOUSE EXTERIOR:

Thanks to Lynda Apel and the many volunteers she assembled, the front of the clubhouse has been re-planted and decorated and many pool visitors have already noticed and given compliments on the new look. The lawns and vegetation in the front of the clubhouse as well as the around the perimeter of the rear parking lot and Artisan's Deck have been cut and trimmed in preparation for summer activities.

At this point, all tasks in preparation for the summer, 2023, have been completed.
