Achievements of Skip and "Team Bayshore"

- Restored Bayshore Committees
  - Resuscitating the Physical Assets, Policies and Procedures,
  - Creating the Sand Lobby Committee, and Safety Committee.
- Created policy of providing Committee reports prior to BOD meetings. Board members now have the ability to review the reports prior to the meeting and ask questions based on these reports.
- Improved decision making process.
  - Written reports now lead to focused and short discussion.
  - Clearly stated motions allow directors to clearly understand the pending action.

President Skip was always asking for volunteers for the Board and for committees members. He added two directors and two committee chairs during Board meetings.

# **Steep Learning Curve**

The Board had four directors with previous experience as a director but no experience with Bayshore's Board. The Board had two returning directors.

Learning Bayshore's By-Laws, Covenants and Restrictions, and Policy and Procedures is a daunting task. Skip experienced a steep learning curve and sought direction from past presidents Fernandes and Brodoway (and other members) for where to look in our guiding documents for understanding and history on contininuing situations.

How will the Board function without Skip as President? Very similar to last year. Team Bayshore still has access to all Skip has learned. As long as we maintain fully functioning committees, Bayshore will continue operating at a high level. However, without committees, directors try to do the work of the committees without the understanding nor time to fulfill the duties and responsibilities of the committee.

In 2017 most Bayshore Committees excelled which contributed to Team Bayshore's success.

Resurrected committees included Physical Assets and Policies and Procedures . The performance of these two important committees was a big part of this year's of success.

Created two committees: the Sand Lobby and the Safety Committee (While a safety committee had been around for years, it was inactive for long periods of time without a chair.) Both "new" committees have been productive for Bayshore.

Bayshore has three committees with long, productive records: Planning, Budget, and Communications. However, the Budget Committee often had to build the budget without input from Physical Assets for repair and improvement budgets. The silent acceptance of the work of the Budget and Physi-Page 3

cal Assets committee demostrates they did their jobs and communicated with members..

Unfortunately, we had two committees that did not exist/perform in 2016-17: Nominating and Social. The Nominating Committee did not exist or did not succeed in finding candidates for the Board. Good news is member Rose Bradshaw has volunteered to lead The Social Committee

The most encouraging facet of the BOD 2017-18 is they operate as Team Bayshore. They will focus on making the best decisions for members based on the information provided by committees and with other input.

were able to come in under budget with a small cushion for 2018.


Clean Up Day does not come together without the time and talent of volunteers. Many thanks to all who made this day happen.

## The Bayshore Book Club

The Bayshore Book Club, which has been going since 2014, is looking for additional members. Over the course of our existence we have read books from a wide variety of genres, both fiction and non-fiction. Group members decide on each selection, and we meet approximately once a month. On May 15, we met to discuss Colson Whitehead's extraordinary novel The Underground Railroad. This book won both the 2016 National Book Award and the 2017 Pulitzer Prize for Fiction, among many other prestigious awards. In Whitehead's telling the metaphorical underground railroad of history is transformed into a literal transportation system whose operation involves actual tunnels, tracks, engineers, and agents. While it is never made clear who dug the tunnels or how, there is a sense that the operation developed over long time periods, with countless participants, and over a wide geographic extent. Of course, by necessity the whole system is shrouded in secrecy, and association with any element of it (as passenger, agent, engineer or supporter) is tantamount to a death sentence.

The central protagonist of the story is a young slave named Cora. She has inherited tenacity and courage from her maternal grandmother, and an imposed self-sufficiency from her mother who has escaped

(before the story begins) from the Georgia plantation where they have all been enslaved. Even among the brutalized slave population, Cora is further outcast because of her orphaned and abandoned status. When she encounters Caesar, a slave newly arrived from Virginia, he plants the idea of escape for the two of them. Before this can occur, Whitehead depicts the casual violence of the plantation slave system through poignant and horrific vignettes centered on the two brothers who own and administer the plantation where Cora has existed since birth, and where she expects to die. After a particularly horrendous beating that Cora receives for an insignificant act of resistance, she becomes more susceptible to Caesar's plan and they make good their escape. In a tie to her mother's earlier (and apparently successful) escape, the slave catcher Ridgeway is immediately on their trail. Some of the key elements of the plot focus on Ridgeway's failure to recapture Cora's mother, and his consequent relentless pursuit of Cora herself.

Following the escape, the story follows Cora and Caesar as they gradually make their way further and further north from Georgia through South and North Carolina, Tennessee and Indiana. In these chapters, the book has been compared to Gulliver's Travels in the sense that each state the escapees encounter presents its own unique take on race and gender relations, slavery, abolition, and the human condition. In tracking out these various conditions, Whitehead relies on both actual history, extant slave narratives, and his own imaginative reworking of these resources to produce a compelling account of both historical slavery and the residual results of our racist past for current issues. Without a hint of being pedantic, The Underground Railroad transmits a wealth of lessons for its readers. Excellent!

We will meet next on 12 June to discuss Christopher Moore's 2014 send up of Shakespeare and Edgar Allen Poe, *The Serpent of Venice*. It promises to be a fun summer read, and if you'd like to join in contact me as above.

### Director nominations open to the floor

President Smith stressed the importance of having a full complement of Directors to sit on the Board, and then asked for nominations from the floor. Member Rose Bradshaw nominated Michael Bradshaw as a candidate for Director representing Division 3. Michael Bradshaw then introduced himself to the attending members. Bradshaw is retired from the military and has had 20+ years of technical writing experience. He has also served as Franklin College Director of Education and Academics.

#### Member Comments

Member Norman Fernandes thanked all of the sitting Directors, followed by applause from the members present.

While the ballots were being counted, President Smith handed out Certificates of Appreciation for Committee Members, and appointed and out-going Directors.

President Smith then requested a vote from the members present for floor-nominated Michael Bradshaw. All present agreed to a vote by a show of hands. The vote from members present was unanimous.

All newly elected Directors were elected for three (3) year terms.

#### Proposed Bylaw Change

Bayshore Beach Club Bylaws currently state in Article IV, Section 1 that "the number of Directors who shall manage the affairs of the corporation shall be not less than seven. At any Annual or Special Meeting of the members duly called for that purpose, the members may change that number to not more than nine." The Board of Directors is recommending a change to allow the number of Directors to be between five and nine.

## Question: Shall the second sentence in Section 1 of Article IV of the Bylaws be amended to read as follows?

"The number of Directors who shall manage the affairs of the corporation shall be not less than five/more than nine."

Justifications: Because a quorum is needed to conduct the business of Bayshore - a quorum being one more than half of the board members - and because Bayshore has had difficulty maintaining a full board, it is recommended that the number of board members be changed to no less than FIVE and no more than NINE.

#### Set membership dues for fiscal year 2017-2018

President Blecher reviewed the proposed budget for the upcoming fiscal year, explaining that it has been discovered that a new roof for the Clubhouse may be necessary. With an estimated cost of \$50,000 for a new roof included in the proposed budget, an estimated \$20,000+ would need to be taken from Bayshore's reserve account to balance the budget if the dues are not increased. Increasing the dues, by the allowed \$10.00 per year, would result in \$10,000+ needed to be taken from the reserve account.

MSP (5-1) to increase the yearly HOA dues amount by the allowed \$10.00 per year, increasing the dues amount from \$230.00 to \$240.00.

MSP unanimously to appoint Kathi Loughman as Secretary-Treasurer.
