### Three Board Seats Up For Election

This May, the Board of Director seats currently held by Michael Bradshaw (Division 3), Kerry Terrel (Division 4) and Mark Mugnai (Division 6) are up for election. While the election is normally held at the May general meeting, the date of that meeting is dependent on the status of the Covid-19 coronavirus and whether social distancing is still in place.

The Nominating Committee meets with prospective candidates and selects a slate that is presented at the April Board of Directors meeting, on an as yet undetermined date. Anyone wishing to run for one of the available seats must have their candidate statements in by April 1 to the Bayshore Beach Club office.

### **Clubhouse Changes**

During the state's directive on social distancing in the wake of the coronavirus update, the Bayshore Beach Clubhouse will be closed to the public, as well as to all groups and activities. This means all weekly activities are on hold until further notice

The start date for this position is Wednesday, May 20, and will end when the 2020 pool season closes on Sept. 26.

### **Michael Bradshaw Takes on Board Vice Presidency**

Michael Bradshaw moved to Bayshore in January 2017, and a few months later, was elected to its Board of Directors. Earlier this year he was elected by his peers to serve as board vice president; he is also Bayshore's webmaster. Now he is seeking re-election to the board in May. A full-time resident at Bayshore with his wife, Rose; and a variety of pets, Bradshaw is retired from a career as a technical communicator and instructional designer and consultant; he explains that technical communication includes web design, along with technical writing and editing and graphic production. He also spent several years serving



in the U.S. Air Force as a linguist, trained in the Czech and Slovac languages. He has a Bachelor of Science degree in physics from the University of New Mexico and a master's degree in adult education and training from the University of Phoenix. He and his wife have eight grandchildren between them and one great-grandchild.

Originally from Lompoc, Calif., he lived in New Mexico from 1977 to 2013, then moved to Salem, Ore. He said he and Rose checked out places to live all along the coast, and rented homes in Bayshore to get to know the community. "We definitely wanted to be close to the ocean," he said. And that led to their purchase of a home in Division 3.

"I find it very rewarding," Bradshaw said of his board service. "I think I've brought some stability to the processes, and have a very mellow and business-oriented personality, as well as quite a lot of experience." He was a board member of Franklin College in Albuquerque.

Bradshaw is seeking a second term because, he said, he still has more to contribute. "I think that (board president) Hollis (Ferguson) and the rest of the gang are pretty much headed in the right direction for Bayshore," he said. "We're getting more business- and member-oriented, and I think that's how it should be."

Bradshaw said he would like to see an upgraded orientation for board members and board officers. "There's no orientation for officers at all, and we need to make sure there is training for committee members too," he said, noting that the Bayshore committees act as advisors to the board.

He's a strong believer that all board members should be involved as much as possible, and practices what he preaches. Bradshaw sits on the Budget Committee, chairs the Policy and Procedures Committee and sits ex officio as webmaster on the Communication Committee. He also directs the twice-weekly tai chi program at the clubhouse.

When Bob Mowrer stepped down as Bayshore webmaster, Bradshaw volunteered to take on that role. "I have a background that allows me to do that kind of thing," he said

Bradshaw said he would like to see division meetings in each of Bayshore's seven divisions. "I believe every division should have a meeting at least once a year, to introduce residents to their director and build some personal contact – kind of like a town hall meeting," he said. "People can bring up concerns and could hold a vote to see how important something is to the division as a whole, and if it's that important, bring it to the board level.

"I'm technically oriented and look at details when they need to be looked at, even as I look at the big picture," he added. "In the past, there have been a lot of spur-of-the-moment votes. I do not make snap decisions or just go along with the group." And he thinks any problem brought to the board should be accompanied by at least one possible solution.

"I want to get everybody involved," he concluded.

## Bayshore Emergency Cache Opening April 11

In the midst of the coronavirus pandemic, we can't forget the need to plan for another potential disaster – a Cascadian subduction zone earthquake and tsunami.

To that end, the Bayshore Beach Club Safety Committee, chaired by full-time resident Melissa Chown, is opening the Bayshore emergency preparedness cache on Saturday, April 11, from 10 to 11 a.m.

The cache, an 8- by 8- by 20-foot shipping container sitting atop a granite foundation at Hilton Park across from the Seal Rock Rural Fire Protection District's Bayshore Station, offers Bayshore residents living in the tsunami hazard zone a place to store a tote filled with items they might need in such an event.

Three times a year the cache is opened for residents to access their tote or bring in a new one. While at present only 15 people have stored totes, the shipping container also is the place where the Safety Committee keeps items that would be needed, should an earthquake and tsunami impact the Bayshore area.

"People who live in the tsunami zone can put personal supplies in the totes so that they can get to high ground quickly without having to take lots of things with them," Chown explained.

"They can know that there's something for them at the top of hill," which is a tsunami gathering point by the fire station and grocery.

The community supplies portion of the cache includes emergency food, camp stoves, propane, water and water filtration systems, cots, medical supplies, tarpaulins, emergency blankets and a couple of large tents.

"Each year we add more to the supplies and get donations from Bayshore members," Chown said. She added that the committee focuses on water filtration rather than on stockpiling lots of water.

Not all of Bayshore is in the tsunami hazard zone, but those who live in that zone are invited to purchase a specific type of 14-gallon Rubbermaid tote to store their supplies. Cost of storage is \$10.

"We ask everyone to use the same totes so they can be stacked," Chown said. While the totes usually can be purchased at Ace, Walmart and Fred Meyer, Chown said she has some available to sell at the cache.

It's up to the individual homeowner what to keep in the tote, Chown said, although each tote owner is given a list of suggested items, as well as items that are not permitted, including ammunition, alcohol and flammables.

"We don't recommend what anyone should put in the tote – we want people to decide what is best for them," she said, noting that items stored range from dog food to flashlights and a change of clothes. The tote agreement, Chown added, states that if an individual tote's supplies are not claimed, they go to the good of all.

"I do not need to know what is in the tote – people just need to sign a form," Chown said. The community portion of the cache is for everyone in Bayshore, tsunami zone or not, including renters and visitors – "people who are stuck here in (a tsunami) but don't live here and are not members of Bayshore."

The cache has been in place since December 2016, thanks to a \$1,500 donation of supplies from the Seal Rock Community Emergency Response Team (CERT). All other expenses and

supplies have come from the Bayshore Safety Committee budget or donations, and everything but individual homeowner totes belongs to Bayshore.

"In 2016 a few people from Seal Rock CERT suggested to Bayshore that if we would set up an emergency cache, CERT would donate \$1,500 worth of supplies," Chown explained. "The Bayshore Board of Directors gave us encouragement to do this.

"If this (tsunami) should happen, people will be stuck around here and someone would have to take care of them," Chown said. "We have tourist rentals, and that will cause a strain on community resources, so it's important for the community to be as prepared as it can be." The April 11 cache opening, Chown said, is for people to bring in a tote, exchange items in their tote, or just look around. She will be there to answer questions.

"We've committed to open the cache three times a year," Chown said of the Safety Committee. The three committee members – Chown, Mike McReynolds and Judith McNeil – are all full-time Bayshore residents and are members of South Lincoln County CERT. They can open the cache when needed as well.

"The cache is not used as much as I'd like," Chown said. "We're trying to encourage people to participate. The committee is open to suggestions and help from any resident. We're willing to talk to people about the cache in general and their own needs."
