Board Election Nears

As President Hollis Ferguson notes, the Board of Directors election is expected to take place June 20. That should give members plenty of time to decide on their choice for three members of the Board.

Six Bayshore residents have submitted their names for election to the Board of Directors – Don Patterson, Division 2; Michael Bradshaw, Division 3; David Hanken, Division 4; Mark Mugnai, Division 6; Kathi Lenz, Division 7; and Brett Sturgeon, Division 7. Board seats open this year are in Divisions 3, 4 and 6.

Election ballots and information will be mailed to all members. If there is any division without representation, the nominee from that division who receives the most votes is selected to fill the first board vacancy. If only one nominee from an un-represented division is on the slate, that nominee is automatically selected. Once all divisions are represented by one board member, any remaining board positions are filled by popular vote. The nominees who receive the highest number of votes are selected unless there are already two board members from that division. If so, remaining nominees from that division are not eligible for election, and the nominee with the candidate with the next highest number of votes is selected.

Letter From the President

Another month on lock down and Bayshore Beach Club is still doing well. Hopefully, at the end of this month there will be at least a partial opening of Lincoln County.

Election of Board Members:

We are planning to have the election of Board members completed by June 20. We are looking for volunteers to help stuff envelopes with election packets.

Pool

A partial opening of the state and county could mean the pool might be opened. The reopening restrictions will determine if the pool will be open at that time or later. Currently the plans are to have the pool ready for opening near the end of May (see update page 3).

We are reviewing the hours that the pool will be open. One part is the confusion about closing. Currently, at 8 p.m. the pool, showers, and recreation area need to be empty of members so attendants can clean and lock up. If members enter to use the pool close to 8 p.m., the attendants cannot leave until later. The difference in closing the pool later is the cost of having the attendants stay later, so this year we will close the door to the pool at 7:30 p.m. This allows for a member to use the pool for a short time more, but everyone must be out of the area by 8 p.m. If you are going to use the showers after swimming, please keep in mind the time so you are out by 8 p.m.

History Project

If you are interested in participating with a group of members who would like to produce a written history of Bayshore Beach Club, please give your name to Leslie O'Donnell, editor of the Bayshore Breeze. The members of that group will decide on how it will be structured to write the history. Tasks of the group include writing, editing, interviews, photography, and collecting historical data, such as photos and pamphlets, and/or as the group defines.

Bayshore Beautification Contest

There are plans afoot to have a design contest. Across the street from the clubhouse is a large lot that needs beautification. Hopefully much of the work can be done by members. Several members have commented on the large parking area in front of the clubhouse at the intersection of Westward Ho, Oceania Drive, and Pacific Way. Concerns include cars shooting across from Pacific Way to Westward Ho, and the abandoned look of the large gravel lot. Some even used the word "ugly."

Here's an idea:

What if we hold a contest to design a more pleasing look for that area? The design would need to include the following:

• Native plants that require little tending.

• A barrier between the Pacific Way curve and the parking lot (could be concrete, rocks, and/or plants).

• Space for parking along Oceania Drive across from the clubhouse.

• Room for the school bus to pick up children at the bus shelter.

Pool Opening Delayed by State

Facilities Manager Bob Tunison announced on May 18 that "after doing some research over the weekend, I discovered that during Phase 1 of "Reopening Oregon," the opening of swimming pools is specifically NOT included. In fact, during the entirety of Phase 1, swimming pools will not be reopened. Since phase one is expected to run for approximately 30 days, this means that our opening date for the swimming pool will be delayed until at least mid June.

"I know that this comes as disappointing news to many of you and I completely sympathize with your feelings. As additional information becomes available, I will be in contact with you ... Hopefully, with much better news!"

Time to Remove Noxious Weeds in Bayshore

The Planning Committee reminds Bayshore members that it has decided not to canvas Bayshore this year for Scotch Broom, English ivy and blackberries. In the past, the Planning Committee and Bayshore office manager Kathi Loughman spent hours canvassing, and sending letters and follow-ups for completion.

This year, the Planning Committee agreed that Bayshore property owners should take responsibility for checking their own property for noxious weeds. The Planning Committee is willing to look at individual lots if a property owner is not able to do so; contact the Bayshore office with your name, phone number and property address if you wish help from the Planning Committee.

In addition, property owners may file a complaint form with the Planning Committee if adjoining properties have noxious weeds. The Planning Committee will follow up on the complaint.

Bayshore C & R (Covenants and Restrictions) Article II, Subsection 4, Noxious Weeds states:

Property owners will be responsible for removal of all noxious weeds from their properties as defined by Lincoln County and State of Oregon regulations.

The Bayshore Board of Directors approved various levels of noxious weed fines at their August 17, 2013 meeting.

Level I Noxious Weeds for 3 bushes or fewer Level II Noxious Weeds for 4-10 bushes Level III Noxious Weeds for 11-25 bushes

Level IV Noxious Weeds for 26 bushes or more

The Planning Committee thanks members who have taken care of their noxious weeds, as well as members who have filed complaint forms. As of the first week of May, the Planning Committee has received about 10 complaints and sent out notification letters.

The Planning Committee notes that Bayshore Facilities Manager Bob Tunison is taking care of Scotch Broom on Bayshore properties.



Bayshore Special Road District

The Bayshore Special Road District meeting minutes for the 4 p.m. April 30, 2020 meeting follow: Attendance: Glen Morris, chairman; Dick Meloy, treasurer; and Lee Davis, secretary (via phone conference). The meeting was called to order and the minutes approved. The next meeting is to be announced. Public Comment: none.

Old Business: none. The Treasurer's Report, dated April 27, 2020, was presented with a balance of \$84,684.

Correspondence:

• Received letter from Roy Kinion, Lincoln County Public Works Director, stating that the Road District is responsible for posting a "No Camping" sign near the Alsea Bay and end of Northwest Bayshore Drive.

• Received letter from a Bayshore property owner requesting speed buttons on Northwest Parker to slow traffic. A letter will be sent to her specifying this procedure required to make a formal request: A petition signed by 60 percent of property owners within 250 feet of where the speed buttons are to be located is required to be submitted to the Road District for consideration and action, if in compliance. The petition must state where the bumps are requested to be placed; include the printed name of the property owner, the address of the property owner in Bayshore, and the property owner's signature. The Road District, may at its discretion, move the proposed location to minimize problems with driveways, mailboxes, etc.

Bills: None.

New Business:

• Motion made and approved to make and install "No Camping" signs near Alsea Bay and the end of Northwest Bayshore Drive.

• Motion made and approved to widen and pave road to create a walking path on south side of Westward from Oceania to Bayshore Drive.

• Motion made and approved to widen and pave road to create walking path from Westward to Admiralty Circle.

• Motion made and approved to blade weeds and then gravel rights of way as needed on all District Roads for road edge protection and safety.

• Speed buttons will be installed in the coming weeks at the Stop signs on Bayshore Drive and Westward, Oceania and Westward, and Bayshore Loop. This project, started last year, has been waiting for specific weather conditions to proceed. The buttons will force traffic to stop at STOP signs, thereby helping to protect walkers, bicyclists, and others from vehicles that choose not to obey traffic laws.

• The Lincoln County work crew will not be doing maintenance work this year as scheduled for late May, due to the coronavirus.
