years in that service, Vivian retired in 2009. Currently, she has three children, eight grandchildren, and one great grandchild!







#### What's the Deal with that RV or Boat?

At times it seems that complaints about RVs and boats can overwhelm the Planning Committee! Please remember that the PC members are not on duty 24/7, are not able to respond to complaints immediately, and do not drive around Bayshore looking for violations. It would be nice if everyone, RV/boat owners and all others, take a few deep breaths, understand the rules for RVs and boats, and then treat each other in ways that are respectful.

If you own a RV or boat and want to bring it to your Bayshore property or if you have friends you are inviting to visit you and they have a RV or boat, it would be good for you to review the Guidelines for Determinations p. 6-7: C & R Article II, Subsection 10 on Vehicles at this link-http://bayshorebeach.com/planning/R7%20Guidelines%20for%20Determination.pdf.

If you are a Bayshore member and you look around your neighborhood or drive into Bayshore and notice an RV or a boat at a property, here are a few things to think about before you fill out that complaint form and send it in.

- 1. First, check out the information on <u>Vehicles</u> in the Guidelines for Determinations p. 6-7: C & R Article II, Subsection 10. Here is the linkhttp://bayshorebeach.com/planning/R7%20Guidelines %20for%20Determination.pdf
- 2. Hit pause for a moment before reacting by considering the following:



- a. It is entirely possible that the owners you are concerned about has applied for and been given a permit for having a RV or boat at their property.
- Members who are actively participating in the construction or reconstruction of their home can apply for and be granted a permit to inhabit a RV parked on their lot for up to a six-month period during construction.
- c. Having an RV or boat on one's property is not considered a violation until it is parked overnight without a permit. In other words, a member can have their unpermitted RV/boat or a visitor's unpermitted RV/boat parked on their property for the day and even into the evening. It is not a violation until an unpermitted RV/boat is kept overnight. If the owner has a permit for their RV, then having it on their property is not a violation unless it is present for more than 5 consecutive days or occupied overnight. (Also see 2b above.) If the owner has a permit for their boat, then they are able to have it on their property permanently as long as it is not stored in the right-of-way and does not block a neighbor's view.

#### Traffic Audit


The Kittelson Engineering (of Eugene Oregon) contract was accepted. Kittelson is to conduct a thorough pedestrian safety audit for Bayshore. The contract amount is for \$34,267.00. The work will begin shortly, with an exact date yet to be determined.

#### Sand Issues

BSRD had an onsite meeting with the Park Service and Tri-Ag (the company BSRD uses for sand removal) to investigate the potential illegal dumping of sand on SW Oceania. We are in the process of contacting legal counsel in regard to BSRD responsibility in this matter.

#### Roadside Vegetation Trimming

Darrin Goodrick is in the process of mowing along the edge of the roads in Bayshore to stop vegetation from encroaching.



#### **NEW BUSINESS**

#### Bills

Tim Malone (BSRD Treasurer) submitted 3 bills for payment.

Payment of \$1,457.00 to Darrin Goodrick for mowing, sign installation, and road work.

Payment of \$220.15 to Newman Signs of Newport for road sign fabrication.

Payment of \$343.00 to Local Government Law Group for legal advice.



The bills were reviewed and BSRD voted unanimously to pay the bills.


#### Parker speeding issue
