
# EDITOR'S MESSAGE



# President's Message




In case you hadn't seen Mike's email.

Members,

I wanted to provide an update regarding Sunshine Behavioral Health's proposed purchase of the Alsi Resort and proposed change of it's current commercial use. Much of this was discussed in last Saturday's BOD meeting, but some members wanted to see some of the specifics I presented since the slides were hard to read.

- The BOD appreciates all of the member's inputs before, during and after the July 28th Special BOD meeting where Sunshine Behavioral Health presented their proposal. As we stated in that Special meeting and again at Saturday's meeting, our governing documents do not allow members to vote on a decision like this directly. Bayshore can only consider what our governing documents cover in determining appropriate commercial use.
- On July 30th, I emailed Dann Cutter (Waldport City Manager) regarding his statement that a residential facility is an outright permitted use. Per Waldport Municipal Code:

Retail Commercial C-1 (current Waldport zoning for hotel lots) Section 16.28.010 A allows: A use permitted outright in the R-3 zone


Residential Zone R-3 Section 16.20.010 G allows: Residential facility as defined in ORS 197.660

ORS 197.660 states: "Residential facility" means a residential care, residential training or residential treatment facility, as those terms are defined in ORS 443.400 (Definitions for ORS 443.400 to 443.455), that provides residential care alone or in conjunction with treatment or training or a combination thereof for six to fifteen individuals who need not be related. Staff persons required to meet licensing requirements shall not be counted in the number of facility residents, and need not be related to each other or to any resident of the residential facility. (emphasis added)

 Sunshine Behavioral Health is proposing a 70-75 bed facility, which would far exceed the 6-15 individuals covered under ORS 197.660.

# President's message cont.

- On July 31st, Dann replied: You hit the nail on the head with the problem. The city of Waldport does not have a proposal in front of us. We were simply asked whether a residential treatment facility was an allowable use in that zone. It is. But obviously, there are constraints and other determining factors, but those really only come in to play when we actually have an actual proposal in front of us. Right now we've been given only a small smattering of information.
- On August 9th I replied to an email from Jeremy Woods of SBH again stating the information required per our Guidelines for Determination I pointed out that they would need to resolve the zoning issue with City of Waldport. I also added in that response:
- Bayshore does not discriminate with our membership. We are unable to assign additional assessments or impose restrictions or requirements upon a specific member that is not otherwise called for or set out in the Declaration or Bylaws. You would need to demonstrate the "desirability for the needs of the Bayshore community" or how it "will benefit the residents of all seven divisions of Bayshore" based on the commercial use itself.
- We gave SBH until August 16th to reply with the missing information identified in that email so it could be discussed at the August 19th BOD meeting. We did not get a reply from them. At Saturday's BOD meeting, the BOD voted to not approve the proposed commercial use due to lack of information and send SBH a letter stating the same. Today I sent SBH that letter.
- There is no further action anticipated on this topic.

# Beach Access task Force

<u>In Attendance:</u> Jana Hanford, John Westhafer, Kenn Apel (Board Liaison)

Kenn provided a brief history of the Task Force over the last two years. The current members of the Task Force members then began discussing options for how Bayshore could provide its members and their family/guests access to the beach. Options include building a walkway out to the beach at the 66C beach access path and/or buying or borrowing a motorized beach chair. The following "assignments" were made:

Jana: will investigate portable and removable beach pathways (e.g., Mobi-Mat) by discussing their use at a Lincoln County beach and also researching these types of portable pathways on the internet.

John: will investigate David's Chair and other motorized beach access chairs, including speaking to organizations that currently use these chairs (e.g., Lincoln City).

Kenn: will speak with the State Park Ranger to understand the length of portable pathways that may be permitted on the beach and investigate local grant agencies that may be able to provide some funding for a project(s). Kenn also will review the dimensions of the Bayshore plot that is used (and possibly could be enlarged) for parking as well as the dimensions of the public pathway easement.

The Task Force will meet again on September 5<sup>th</sup> at 1:00pm.


# Special road district

All information below copied from C&Rs, guidelines for determination, articles of incorporation, Policies & Procedures and Welcome packets.

### BEACH ACCESS

Please only use designated public beach accesses marked with signs to get to the beach.

### • QUIET TIME

The hours of 10pm to 7 am are required quiet time per Bayshore and Lincoln County ordinance.

### • RV Parking

No RVs may be parked on Bayshore properties or along the roadside without previous permission of the planning committee & within limitations set forth.


### • PARKING

Please Park in the garage or driveway. The roads are narrow, and vision can be obstructed by vehicles along the road. SPEED LIMIT IS 25MPH.

### • PETS

Per Lincoln County ordinance you must keep your pets confined to your yard or on a leash. Also, you must clean up after them.

• SAFETY

The ocean can be very dangerous. Please watch your children very carefully. Seals and seal pups, snowy plovers and other marine animals are protected species. Keep at least 200 feet away and keep your pets from running up on them. Federal law prohibits touching, feeding or disturbing marine mammals.

FIRE

Fire is a very real danger. Fireworks are NOT allowed in Bayshore or on the beach and are a serious hazard during dry weather. OAR 736.021.0100 prohibits "possessing, discharging or causing to be discharged any firecracker, explosion, torpedoes, rockets, fireworks or other similar devices" on Oregon beaches. Beach fires are ONLY permitted on open sand west of the dunes and cannot be started in areas of built-up driftwood.

- Lots must be kept clean and in visually pleasing condition. Keep weeds, cleared and trimmed trees within the C&R limits. Garbage and other waste shall be placed in sanitary containers with lids and removed weekly. Garbage cans stored near the street must be screened from the view.
- Be kind to your neighbors.
